Our Vision & Mission

When we consider sustainability, our vision is to provide the highest quality medical nutrition with the lowest level of environmental impact. Our mission is to become a Net Zero business by 2050.

Measuring Our Progress

To do this, we will measure and reduce our carbon footprint year-on-year. This footprint will be measured by Positive Planet.

Net Zero Goals

- ➔ Reduce scope 1 & 2 emissions by 100% by 2030.
- ➔ Reduce scope 3 emissions by 21% by 2030.
- ➔ Reduce our total emissions by ~90% by 2050.



Positive Planet is an external third party and a member of the Carbon Accounting Alliance.

Positive Planet follow GHG Protocol standards as they measure our Scope 1, Scope 2, and Scope 3 carbon emissions.

Why Sustainability Matters to Us

Achieving sustainability is vital for everyone. It is why taking urgent action to combat climate change and its impacts became a United Nations Sustainable Development Goal in 2015. It is why the NHS and HSE are moving towards net zero positions. It is why Nualtra wants to provide the highest quality of medical nutrition with the lowest level of environmental impact.

Past Achievements

To date, the use of Nualtra products has saved **£30+ million** for healthcare economies, supporting ONS usage in becoming more financially sustainable.

Over 79 million servings of oral nutritional supplements have been provided by Nualtra.

Here's how we got to this point...

**Positive Planet
Certified**

Bronze Award

December 2024

Nualtra's first carbon footprint measurements were completed and finalised.

October 2024

The UK team completed a carbon literacy course, and all attendees are now carbon literate certified.

June 2024

We formed an internal sustainability taskforce to lead our sustainability initiatives.

November 2020

We became the first company in the Republic of Ireland to re-introduce tetra packaging to the adult ONS market.

August 2018

Nualtra became the first ONS company in the UK & Republic of Ireland to remove plastic straws from product packaging.

February 2025

The Irish team completed a carbon literacy course. We also achieved Positive Planet Bronze certification.

November 2024

We started our supply chain engagement strategy. More details can be found in our Net Zero Annual Report.

August 2024

We created our first Nualtra Sustainability Policy.

March 2023

Our sample services started exclusively using recyclable packing materials for patient and HCP deliveries.

February 2020

We became the first company in the UK to re-introduce tetra packaging to the adult ONS market. Our Tetra Pak packaging units contain approximately 72% plant-based renewable materials.

Launched an electric vehicle incentive scheme for UK employees.

Created improved recyclability resources.

**February
2026**

Over 50% of Nualtra employees will have completed carbon literacy training and gained carbon literacy certification. Nualtra will become a 'Bronze Carbon Literate Organisation', accredited by The Carbon Literacy Project.



**February
2025**

The Irish team completed Carbon Literacy Training.

Achieved Positive Planet Certified Bronze Award to recognise our ongoing achievements in sustainability.



**June
2025**

Published our first Net Zero Annual Report including our carbon footprint reduction plan and Net Zero Strategy.

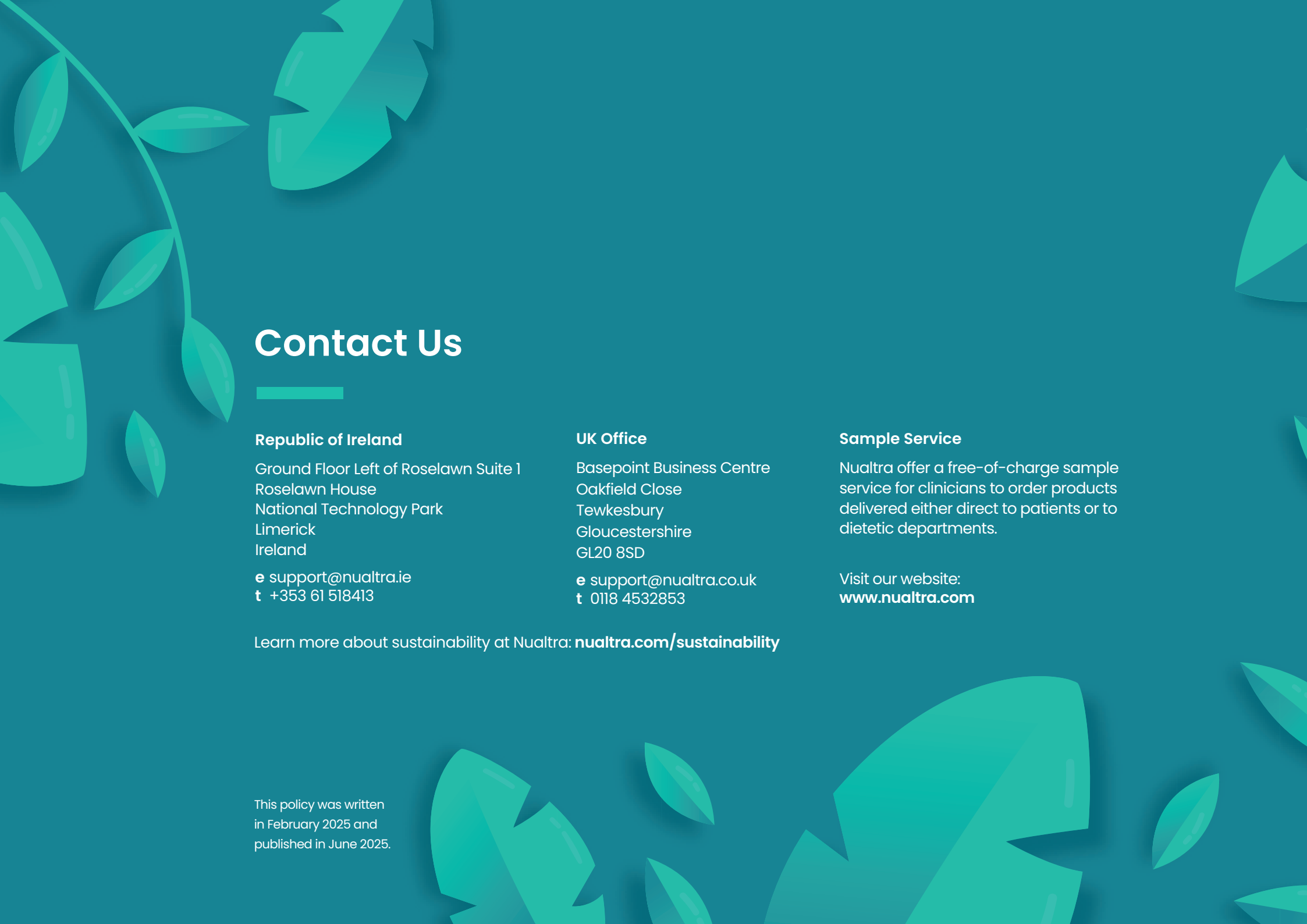
Published our online carbon footprint dashboard.

2026

Further improved our product range's packaging by increasing the percentage of plant-based materials in our tetra cartons, transitioning to polyolefin plastic bottle sleeve labels, and switching to recyclable sachets for our powdered products.
